

## **Administrative Amendments to Class EAs – July 6, 2020**

### **Director’s Notice of Amendment under s.15.4 of the *Environmental Assessment Act***

The following are amendments to the approved class environmental assessments to replace terms or phrases used in each of the approved class environmental assessment and these amendments are being made under s.15.4 of the *Environmental Assessment Act*.

For greater certainty, where an approved class environmental assessment includes the terms “Notice of Completion” or “Notice of Addendum”, “issue/issued” or “comment period” those terms shall continue to be used.

**Municipal Class Environmental Assessment** approved by the Lieutenant Governor in Council on October 4, 2000 under Order in Council 1923/2000.

A new section, *Section A.1.8 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Completion of Environmental Study Report” is replaced by the term “Notice of Completion”.

The terms “Revised Notice of Completion” and “Notice of Filing of an Addendum” are replaced by the term “Notice of Addendum”.

The term “review period” when used in relation to a notice is replaced by the phrase “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment for **Remedial Flood and Erosion Control Projects** approved by the Lieutenant Governor in Council on June 26, 2002 under Order in Council 1381/2002.

A new section, *Section 2.5 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Filing” used in relation to the making publicly available a Project Plan or Environmental Study Report, is replaced by the term “Notice of Completion”.

The term “Notice of Filing of Addendum” is replaced by the term “Notice of Addendum”.

The term “filed” when used in relation to a Notice of Completion or Notice of Addendum is replaced by the term “issued”.

The term “review period” when used in relation to a Notice of Completion or Notice of Addendum is replaced by the phrase “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment for **Minor Transmission Facilities of Hydro One** approved by the Lieutenant Governor in Council on November 16, 2016 under OIC 1726/2016.

A new section, *Section 1.5 – General*, is added to the class environmental assessment to include the following paragraphs:

The term Notice of Filing of Addendum is replaced by the term Notice of Addendum.

The term “distributed” when used in relation to the Notice of Completion or Notice of Addendum is replaced by “issued”.

The term “review period” when used in relation to a notice is replaced by the phrase “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment for **Activities of the Ministry of Northern Development and Mines under the Mining Act** approved by the Lieutenant Governor in Council on December 12, 2012 under OIC 1952/2012.

A new section, *Section 2.6 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Completion of the Final Environmental Study Report” is replaced by “Notice of Completion”.

The terms “Notice of Filing of Addendum” and “Revised Notice of Completion” are replaced by the term “Notice of Addendum”.

The term “released” or “filed” when used in relation to a Notice of Completion or Notice of Addendum is replaced by the term “issued”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

**Class Environmental Assessment for Waterpower Projects** approved by the Lieutenant Governor in Council on September 24, 2008 under Order in Council 1623/2008.

A new section, *Section 2.7 – General*, is added to the class environmental assessment to include the following paragraphs:

The terms “sent” and “distributed” when used in relation to a Notice of Completion or Notice of Addendum are replaced by the term “issued”.

The terms “review period”, “notice of completion period” and “environmental review period” when used in relation to a notice are replaced by “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment for MNR **Resource Stewardship and Facility Development Projects** approved by the Lieutenant Governor in Council on December 11, 2002 under Order in Council 2211/2002.

A new section, *Section 2.7 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Completion, Opportunity to Inspect the Final Environmental Study Report” is replaced by “Notice of Completion”.

The term “Revised Notice of Completion” is replaced by the term “Notice of Addendum”.

The term “sent”, “posted”, “released” or “filed” when used in relation to a Notice of Completion or Notice of Addendum is replaced with the term “issued”.

The term “response period” when used in relation to a notice is replaced by “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment for **Provincial Parks and Conservation Reserves** approved by the Lieutenant Governor in Council on September 23, 2004 under OIC 1900/2004.

A new section, *Section 3.7 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Completion, Opportunity to Inspect the Final Environmental Study Report” is replaced by “Notice of Completion”

The term “Revised Notice of Completion” is replaced by the term “Notice of Addendum”.

The term “sent”, “posted”, “released” or “filed” when used in relation to a Notice of Completion or Notice of Addendum is replaced with the term “issued”.

The terms “review period” and “response period” when used in relation to a notice is replaced by “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

Class Environmental Assessment Process for **Management Board Secretariat and Ontario Realty Corporation** approved by the Lieutenant Governor in Council on April 28, 2004 under OIC 913/2004.

A new section, *Section 1.4 – General*, is added to the class environmental assessment to include the following paragraphs:

The term “Notice of Completion of an Environmental Study Report” is replaced by “Notice of Completion”.

The term “review period” when used in relation to a notice is replaced by “comment period”.

The term “Notice of Filing of Addendum” is replaced by the term “Notice of Addendum”.

The terms “sent” or “filed” when used in relation to a Notice of Completion or Notice of Addendum is replaced with the term “issued”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.



Class Environmental Assessment for **Provincial Transportation Facilities** approved by the Lieutenant Governor in Council on October 6, 1999 under OIC 1653/1999.

A new section, *Section 1.8 – General*, is added to the class environmental assessment to include the following paragraphs:

The terms “Notice of Submission” for a Transportation Environmental Study Report”, and “Notice of Submission” for the Design and Construction Report are replaced by “Notice of Completion”.

A notice given to notify the public of an addendum to a Transportation Environmental Study Report or an addendum to a Design and Construction Report is a “Notice of Addendum”.

The term “given” when used in relation to a Notice of Completion or Notice of Addendum is replaced with the term “issued”.

The term “review period” when used in relation to a notice is replaced by “comment period”.

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.

**GO Transit** Class Environmental Assessment Document approved by the Lieutenant Governor in Council on December 13, 1995 under Order in Council 2316/1995.

A new section, *Section 1.7 – General*, is added to the class environmental assessment to include the following paragraphs:

A notice given or filed to notify the public of an addendum to an Environmental Study Report is a “Notice of Addendum”

The terms “filed”, “given” and “placed on the public record” when used in relation to a Notice of Completion or Notice of Addendum are replaced with “issued”

The term “review period” when used in relation to a notice is replaced by “comment period”

A Notice of Completion or Notice of Addendum shall set out the dates of the beginning and end of the comment period required by the Class EA following the issuance of a Notice of Completion or a Notice of Addendum.
